

RELEASE OF LIABILITY, INDEMNITY AND ASSUMPTION OF RISK AGREEMENT

date written bel	f Liability, Indemnity and Assumption of Risk Agreement (the " <u>Agreement</u> ") is made and entered into on low by the undersigned, an adult resident of the State of and my heirs or other persons or ay have a right to make a claim on my behalf (hereinafter, collectively, "I" or "me").
(initial)	I desire to participate and to have my dog participate in dog training classes, consultations, workshops, social activities, and other related activities (the " <u>Activity</u> " or " <u>Activities</u> ") offered by DMNM, LLC d/b/a Tailwaggers Doggy Daycare, a Wisconsin limited liability company, and NMW Holding, LLC, a Wisconsin limited liability company (collectively, " <u>Tailwaggers</u> ") located at As lawful consideration for being permitted by Tailwaggers to participate in the Activities, I agree to all of the terms and conditions set forth in this Agreement.
(initial)	I UNDERSTAND THAT TAILWAGGERS CANNOT AND EXPRESSLY DOES NOT GUARANTEE THE SUCCESS OF ANY ACTIVITY. TAILWAGGERS MAKES NO REPRESENTATIONS, GUARANTEES, PROMISES, IMPLIED OR EXPRESSED, THAT ANY TRAINING RECEIVED FROM TAILWAGGERS WILL CURE A DOG OF DANGEROUS PROPENSITIES.
(initial)	I AM AWARE AND UNDERSTAND THAT THE ACTIVITIES ARE DANGEROUS ACTIVITIES AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH FOR ME, ATTENDING GUESTS, AND MY DOG, WHICH INCLUDES, WITHOUT LIMITATION, RISK OF ILLNESS, FALLS, AND/OR BITES. I ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING AND ALLOWING MY PET TO PARTICIPATE IN THE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY OR DEATH WHETHER CAUSED BY THE NEGLIGENCE OF TAILWAGGERS OR OTHERWISE (OTHER THAN INTENTIONAL MISCONDUCT BY TAILWAGGERS).
(initial)	I hereby expressly waive and release any and all claims, now known or unknown, against Tailwaggers and its officers, directors, employees, agents, affiliates, members, successors, and assigns (collectively, "Releasees"), on account of injury or death arising out of or attributable to my participation in, or my pet's participation in, the Activities, whether arising out of the negligence of Tailwaggers or any Releasees or otherwise (other than intentional misconduct by Tailwaggers or a Releasee). I covenant not to make or bring any such claim against Tailwaggers or any other Releasee, and forever release and discharge Tailwaggers and all other Releasees from liability under such claims.
(initial)	I shall defend, indemnify, and hold harmless Tailwaggers and all other Releasees against any and all losses, damages, liabilities, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorney fees and fees and the costs of enforcing any right to indemnification under this Agreement, incurred by Tailwaggers or any Releasee, arising out or resulting from any claim of a third party related to the Activities.
(initial)	I represent and promise that I am the lawful owner of the dog named below my signature.



(initial)	I understand that I am solely responsible for any harm, including to any other pet(s), to the employees or invitees of Tailwaggers, or the equipment, facilities, or other property of Tailwaggers, caused by my dog(s). I also agree that Tailwaggers shall not be responsible or liable for any lost or damaged personal property belonging to me.
(initial)	I understand that by enrolling my dog into any of the Activities, that Tailwaggers has relied upon my representation that my dog is in good health and has received the necessary vaccinations (or equivalent alternatives) as agreed upon by my veterinarian. I agree to Tailwaggers' decision to obtain medical treatment for my dog(s) if he/she appears ill, injured or exhibits any other behavior that would reasonably suggest that my dog(s) may need immediate medical treatment. I agree to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment.
(initial)	I understand that Tailwaggers has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression, including but limited to biting humans or other animals, Tailwaggers reserves the right to refuse service. I also understand that all biting incidents may be reported to the local authorities to the extent required by law.
(initial)	I agree to abide by all rules and regulations presented before, during, or after the Activities.
(initial)	I understand that refunds of training fees will be given only at the discretion of Tailwaggers, and I understand that I may be charged for an Activity session if I give less than a 24-hour notice for cancellation.
(initial)	Tailwaggers loves to post pictures and videos on Facebook, their website, and/or in ads. I agree to allow Tailwaggers to use my pet(s)' name and any images or likeness of my pet taken while he/she is at Tailwaggers, in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and I release to Tailwaggers all rights that may possess or claim to such image, likeness, recording, etc.
